In light of the recent Equifax data breach, I'd like to encourage YOU, our member, to become aware of the services available to you to protect your hard earned assets. We are now offering the ability to turn off and on your debit cards through Home Banking and the MyMobileMoney App. We are partnering with Sollievo to make a discounted Identity Theft Protection Service called CyberScout available to you. All BFCU Debit and Credit cards have been upgraded to utilize the EMV Chip Technology to help prevent skimming and counterfeiting of your cards. We are working diligently with the Fraud Prevention Team to block common fraudulent activity on your debit cards. You can help us by letting us know when you travel to avoid a temporary shutoff of your BFCU Debit and Credit Cards.

Looking forward into 2018, I am excited to be introducing a new Credit Card App that will give you the ability to pay your bill, view transactions, mark the card as lost/stolen and dispute transactions. I will continue to seek new services and products that will benefit you as our member. I am also looking forward to new growth in our membership, with your help. As a reminder, your parents, grandparents, siblings, spouses, children, grandchildren and economic household members are all eligible to join because you belong. Travel Alert!!!

As a reminder – Let us know if you will be traveling! Due to an increase in ATM PIN Fraud, we are working with our Fraud Watch Plus Protection Debit Card Service to keep your accounts safe. In doing so it has become more difficult for fraudsters to use your MasterCard Debit Card outside of your typical spending radius. Because of this change, it is very important that you notify the BFCU Team at the office that you will be traveling. An alert will be placed on your debit and/or credit cards to prevent any temporary closure of your cards while you are out of town.

MyMobileMoney App

MyMobileMoney is a new Debit Card App available to all members for use as of November 22, 2017. This app allows alerts to be placed on debit cards that can be sent to your mobile phone or email. These alerts can be set for a number of different situations such as where the transaction takes place, the type of transaction or how much is being spent daily on each debit card. More than one card can be added to this app if you have joint owners on a checking account and want to utilize one mobile device to track your debit card spending. One of the most exciting features of the app is to turn the debit card on and off when you are not using it. Imagine how much less of concern debit card fraud would be if your card isn't even turned on when you know your card isn't being used. From the Assistant Loan Officers Desk

We have an exciting new product called Assurance Plus that members financing their vehicles and purchasing GAP Insurance will receive at no additional charge! In the event of an accident, GAP insurance will still cover the difference between what your insurance would pay out for a totaled vehicle and the amount that is still owed on the loan. However, this new feature will give you a reimbursement for your deductible on a claim to your insurance up to \$500 for damages that didn't total the vehicle. There is no limit to the number of times a year you can claim this deductible. Not only is this service good for three years, but it is valid on any vehicle that you are on the title and insurance for. This product is only offered on vehicle loans that have been processed through our office since July and going forward. So if you are in the market for a new vehicle in the coming months, consider financing with BFCU. Call Jessica, our Assistant Loan Officer, for more information.
